

Monsignor Kelly Catholic High School 2021-2022 Tuition and Fees

MKCHS offers, as the primary assistance, sliding scale tuition. All families must create a FACTS tuition payment account; **if you do NOT currently have a Kelly High School student, set up the FACTS tuition payment account.**

1. Go to www.mkchs.com
2. Click on the COMMUNITY link
3. Click on CURRENT Parents
4. Click on the UNDERSTANDING FACTS icon
5. Scroll down to FACTS Tuition Enrollment
6. Click on the link: FACTS Tuition Enrollment
7. Click on CREATE A USERNAME AND PASSWORD link - (note: If you are/were enrolled at a feeder school, and your information is still the same, use the same log-in when you are asked to create a username and password. Then select MKCHS as the school. FACTS will pull some of your information if you had an account at a feeder school.)
8. Enter/update your information for your MKCHS student
9. Click on Create Payment Plan and proceed as directed. There are three payment options:
 1. Annually
 2. Bi-annually
 3. Monthly (10 payments)
10. Complete and submit the FACTS Grant and Aid application only **if applying for placement in categories 1-4. This step requires uploading your 2020 tax return and all supporting schedules.** Click [here](#) to access FACTS Grant and Aid application.

Once tuition categories have been confirmed, Kelly's Business Office will bill your tuition via your FACTS tuition account. In order to receive your sliding scale discount, the FACTS Grant & Aid Application must be completed by May 31, 2021. Failure to meet this deadline will result in automatic category 5 billing.
